BOARD OF ALDERMAN MEETING

Held their regular monthly meeting on February 4, 2019 at 8:00 PM in the Jimmie L. Morris Boardroom

- I. Call to order by Mayor Chad Braxton.
- II. Roll call Those Present: Mayor Chad Braxton, Alderman Keith Cannon, Alderman Todd McMillen, Alderman Dennis Smith, and Alderman Billy Whitford.
- III. Invocation by Alderman Cannon.
- IV. Pledge of Allegiance.
- V. Approval of minutes from last meetings Alderman Whitford made a motion to approve minutes. Motion was seconded by Alderman Smith and carried. Vote 4-0.
- VI. Approval of Cash Receipts and Disbursements. Alderman Smith made a motion to pay bills. Motion was seconded by Alderman Whitford and carried. Vote 4-0.
- VII. Nominations for open seat on the Board of Alderman. There were three nominations for Alderman Dunn's seat on the Board of Alderman. They were: Andrew Black Jr. of 805 College Street, Thad Jones of 318 Moore Street and Stephen Belrose of 201 White Street.

Close nominations for open seat on the Board of Alderman. Alderman McMillen made a motion to close open nominations. Motion was seconded by Alderman Smith and carried. Vote 4-0. Stephen Belrose will be the replacement Alderman by a vote of 4-0.

VIII. Police Report was presented by Chief Jenkins. We are planning a pork chop plate sale for March 16th to support National Night Out. I attended the workshop in Cherokee, NC from January 12th through the 15th. National Night Out will be held on Saturday, August 10th. We are working on completing 2019 in service training. Attended a law enforcement appreciation at West Craven High School on the 17th. On the 19th Officer Anthony attended a law enforcement appreciation at Juniper Chapel Church. The winner for Do the Right Thing for January was Ty'Jire Anthony. We assisted Craven County Sheriff's Office in the search of a small child. Mutual aid agreements have been resigned for all local county agencies. Attended a meeting in Havelock with other agency heads to share information and communicate.
